Introduction and Announcements

Hymel welcomed those in attendance and requested self-introductions by the members, alternates, staff, and guests.

A. <u>Closed Session</u>

Public Employee Performance: Executive Officer Evaluation Pursuant to Government Code – Section 54947

Hymel noted the Closed Session on Executive Officer Performance was optional based on Board interest in having one. He said Consent Calendar Item 4 was developed by the Executive Officer Work Plan Committee regarding this matter. There was no request for the Session.

C. Executive Officer's Report (Cassingham)

1) Report #10 on Strategic Plan Implementation

Cassingham summarized Report #10 and introduced Outreach Consultants Price and Mullen. She said the Outreach Subcommittee will meet again on January 8 to continue their work on the Governing and Executive Boards' January 16 Workshop on the Next Generation System. Pearce said the November 29 Member Orientation was beneficial and garnered useful feedback for the Workshop.

2) <u>Governing Board Members and Alternates sand Executive Board Members – Recognition Policy and Budget</u>

Cassingham said consideration of a formal Recognition Policy and Budget had been requested by former MERA President Revere. She is recommending continuation of the use of Resolutions of Commendation acknowledging member service and special contributions to MERA at no additional expense.

M/S/P Irving/Pearce to continue the use of Resolutions of Commendation to acknowledge service and contributions of Governing Board Members and Alternates and Executive Board Members upon retirement or resignation with no increase in MERA's Operating Budget.

3) Other Information Items

Cassingham recapped the November 29 Member Orientation attended by 19 members from 11 agencies. A tour of the County Communications Center preceded presentations in the EOC by the Executive and Operations Officers. She thanked Sheriff Doyle for hosting the event.

Cassingham distributed copies of the latest MERA membership lists and reminded members about meraonline.org as a resource. She is also working on completing the links project to MERA's website by year-end. 13 member agencies have linked their websites to MERA's to date. She rechecks member sites before recontacting about links. Seyler asked if a template could be provided to guide setting up links, where to locate them on member sites, and some examples. Cassingham said she would include this information in her next email on the project.

D. Operations Reports

1) MERA System Operations Report (Chuck)

Chuck presented his System usage reports and charts for November 2012 and the last year. There were nearly 430,000 transmissions last month for a total of 721 radio hours or 10 transmissions per minute throughout a 24-hour period. Busies are down to .4 seconds per busy. For 2012, there have been 4.5M

system transmissions and 7,500 hours of air time. The huge spike in busies occurred in 2008 due to storm activity. System expansion and training in 2010 help reduce busy seconds.

He reviewed the East and West System Activity Charts and channel availability. Both charts include 2018 projections which is the date planned for the new System. The majority of traffic is on the East System. Additional radios may force the addition of more channels or a move to a new system. Operationally, the system is performing well. Tyrell-Brown asked about the use of the VHF overlay. Chuck said this protocol is only used during storms. It was tested recently and it performed well. She asked if the protocol, when used, could be shown in future graphs. Chuck said this could be projected and such information could be a big help. Hymel asked how the system performed in the recent storm. Chuck said the count was up but no noticeable change in busies since the storm was small and concentrated.

2) Other Information Items

Pearce reported on the status of Director Naso's coverage issues. An Executive Board Subcommittee was appointed and several meetings have been convened to look at different technologies and workarounds currently in place, new technologies and other sites that could be helpful in addressing coverage issues. He thanked Naso for bringing this forward and anticipated good short and long-term solutions. Cassingham also thanked Stevens for his contributions to the Subcommittee.
