**SUBJECT:** AGENDA ITEM **B-1**: PROPOSED **PRELIMINARY** FY19-20 MERA  
OPERATING, NEW PROJECT FINANCING AND  
2010 REFUNDING REVENUE BONDS BUDGETS

Recommended Action: Based on Finance Committee review and recommendation, approve the Proposed **PRELIMINARY** MERA FY19-20 Budgets to the Executive Board for Operating, New Project Financing and Refunding Revenue Bonds for immediate distribution to Member Agencies. On May 1 the Executive Board will review and recommend **FINAL** Proposed Budgets For Governing Board approval on May 8.

Background: Total Proposed Preliminary Operating Budget for FY19-20 is \$1,991,510 which represents a 3.1% increase over prior year's budget. A recent history of total annual Operating Budgets and percentage changes over prior years is as follows:

The second budget is for the 2007 Citizen Bank Loan Note for supplemental capital borrowing. The Governing Board directed that this payment remain the same through the life of the Note.

The third budget is the Annual Debt Service for the Refunding Revenue Bonds and there is no discretion in the payment amount.
