Transportation & Traffic Operations The requests (attached) were vetted through the Operations Issues Work Group and are found to be acceptable given that the agencies have either acknowledged that the radios do not have 700Mhz capability and therefore will not work on the Next Gen System (single band requests) or the agencies have provided an additional band for future functionality (dual-band requests).

The Additional Radios Policy and Procedures requires the entity to pay for these radios and all costs associated with programming and alignment. In addition, training

is recommended for all users before the radios are released for use, based on the end user curriculum approved by MERA. Training can be provided by the entity if they have an approved trainer on staff, or provided by Marin County staff with all costs borne by the entity.

Please accept this letter as a formal request for the addition of two aliases to the MERA system. I am including a request on behalf of the City of Belvedere as a courtesy.

Tiburon Police Department - Addition of 1 alias - Portable radio for patrol staff

Belvedere Police Department - Addition of 1 alias - Mobile radio for Police Chief vehicle

We propose using single-band radios for use on the existing MERA system and it is understood that a new radio will have to be purchased to work on the MERA Next Gen System.

I am aware that the addition of these is not a commitment for replacement and that I must provide my own equipment, to be programmed at the expense of our agency. We authorize MERA to remove the code plug programming at such time we no longer need the radio. Additionally, radio training will be provided to end users.

Persuant to our existing agreement (ref. "MERA\_LETTER\_OF\_AGREEMENT\_Use\_of\_System \_and\_Radios\_Golden\_Gate\_National\_Parks\_Conservancy\_7-11-19") the Golden Gate National Parks Conservancy (Parks Conservancy), with support from our One Tam partners at Marin Municipal Water District, is requesting permission to add an additional (5) portable radios to the MERA system. Point Reyes National Seashore, as an approved MERA non-member agency, is requesting permission to add one additional mobile radio to the MERA system. This mobile radio will be installed in our new patrol/rescue vessel (Rescue 27) and will be used to communicate with other Marin County agencies, primarily Marin County Fire and Marin County Sheriff's Department, during interagency response on Tomales Bay and the outer coast.

The mobile radio is a Motorola APX8500. This is a dual band radio that includes one band for use on the existing MERA system and a second 700 Mhz capable band for future use on the MERA Next Gen System.

National Park Service Law Enforcement Rangers stationed at Point Reyes National Seashore are the only individuals authorized to operate Rescue 27. All rangers receive initial MERA radio training upon arrival at their duty station and utilize it on a daily basis when communicating with Marin Communications Center and Woodacre Dispatch. All rangers will receive additional training and orientation to the new mobile radio installed on Rescue 27.

The National Park Service acknowledges that in the event MERA coverage is no longer necessary, we authorize MERA to remove the code plug programming from this radio.
