Recommended Action: Accept the recommendation of the MERA Next Generation Project Oversight Committee to commence contract negotiations as recommended by the NGPOC Selection Subcommittee.

Background:

MERA received a single proposal from Motorola in response to the Vendor RFP. Since that time, the proposal was made available to members of this Committee, the Operational Issues Working Group, MERA staff, DPW staff and Federal Engineering for initial review and to identify issues needing clarification. That review has been completed and the clarifying questions were forwarded to Motorola for a response. We expect the majority of those responses prior to this meeting.

In addition, a Site Visit team that included end users as well as MERA and Marin DPW staff conducted a site visit to the Silicon Valley Regional Interoperability Authority on 08/31/16 to learn of their experiences in their current project with Motorola. A summary of those observations were provided to the Selection Subcommittee for their consideration and will be made available to the Negotiating Team. This agency was a recommended reference from Motorola.

A second site visit is scheduled for El Paso, TX on 09/09/16. Those comments will also be routed to the Selection Subcommittee and will be made available to the Negotiating Team. This agency was not listed by Motorola and was recommended by Federal Engineering.

The Operations Working Group is also conducting a number of additional reference checks by phone with additional Motorola clients that will be handled similarly to the site visits.
