## 5) Key Project Summary Details:

- a. Code Plugs
  - i. Motorola developing Code Plugs for NG radios.
- b. Connectivity (Dispatch, FSA, Wi-Fi)
  - i. Pilot program: EOF, NPD, and SRF connected. Fairfax in progress.
- c. Connectivity Project: Marin IT has offered to build and maintain the IP network. Agencies will pay providers for private line connection charges monthly. (est. \$325/month/site) and Marin IT will bill approx. \$600/month/site to purchase equipment, coordinate installation, provide 24x7 monitoring, repair and replacement services for 5 years. Connections to be ordered by 01/29/24.
  i. Marin Fire Chiefs Association briefed on 01/18/2024.
- d. Microwave Network Installations in progress.
- e. End User Training Training Committee met with MSI on 1/19/24. MSI Sponsored End user training for dispatch (02/20-21/24) and field users (02/22-23/24) is scheduled. Invitations in progress.
- f. Technician Training: 1 class in February, 2 in classes in March, 2 classes in May and 2 classes in June. Attendees are the DPW Communications Division staff.

## g. FCC Licenses:

i. FCC Microwave Construction Licenses were set to expire 12/31/23. MERA requested and received an extension until 04/30/24.

ii. FCC LMR Construction Licenses are set to expire 02/29/24. Currently drafting an extension request if needed.
