SUBJECT: MERA NG Project Construction Bid Package #3 Final Change Order

Reconciliation and Close Out Approval (Action Item)

Recommended Action: Approval of the final change orders and close out for BP #3.

Background:

On 10/26/22, the MERA Governing Board approved the awarding of Bid Package #3 to Fidato with an award of \$3,612,000 and a contingency of \$541,800. This Bid Pacakge includes Wolfback, Mill Valley Water Tank, Skyview Terrace, and Tomales. On 11/9/22, the MERA Governing Board approved CO #1 for \$484,481, to move supply chain items from BP#4 up into BP#3 so the orders could be placed for shelters, generators, and other electrical components.

Since then, there have been several small change orders that were approved and reported on (CO2-7). The following table is record of the entire Bid Package #3:

Since BP3 was awarded to Fidato on 10/26/22 and BP4 was awarded to Fidato on 12/14/22 staff has worked these packages together with the Construction Administrator to balance the work effort, manage the site access and schedule and recognize time and cost efficiencies where possible. With the approval of change orders 2-8 the total additional cost for this Bid Package is \$162,468.67 (the move of \$484,481.00 from BP4 was a reduction to that package Budget) which is within the approved contingency and within the Fund 38 Project Budget.
